<b>SECTION III: HAZARDOUS IDENTIFICATION</b>	
<p><b>Appearance and Odor:</b> Acid is a clear to cloudy liquid. Lead is metallic gray in color. Formed lead dioxide is a dark brown in color with a slight acidic odor.</p> <p><b>Routes of entry:</b>  <b>Sulfuric Acid:</b> Inhalation, skin, ingestion.  <b>Lead:</b> Inhalation and Ingestion. Ingestion of lead occurs by hand to mouth contamination. After handling lead or its compounds, hands must be washed prior to eating or drinking. Metallic lead cannot be absorbed through the skin.</p> <p><b>HMIS label rating for sulfuric acid:</b>  <b>Health: 3 Flammability: 0</b>  <b>Reactivity: 2 Other: 0</b></p>	<p><b>Health Hazards (Acute &amp; Chronic)</b>  <b>Acute:</b> Sulfuric acid exposure may cause irritation of the skin, corneal damage of the eyes, irritation of the mucous membranes and upper respiratory system, including the lungs. Acute lead exposure may cause GI upset, loss of appetite, diarrhea, constipation, fatigue, joint pain, and difficulty sleeping.  <b>Chronic:</b> Exposure to lead may cause anemia, kidney damage and damage to the central nervous and reproductive systems. Lead exposure may also affect developing fetuses in pregnant women. Chronic exposure to sulfuric acid may cause scarring of skin and mucous membranes, bronchitis, contact dermatitis, and erosion of tooth enamel.</p>

The first number represents the <b>Health</b> hazard, second number represents <b>Fire</b> hazard, and the third number represents the <b>Reactivity</b> hazard. The fourth space identifies the hazardous material, which is acid and/or typical recommended personal protective equipment, i.e., safety glasses, rubber or neoprene gloves etc.</p>

<b>SECTION VI: ACCIDENTAL RELEASE MEASURES</b>
<p><b>STEPS TO BE TAKEN IF BATTERY IS BROKEN:</b>                  Neutralize exposed battery parts with soda ash or sodium bicarbonate until fizzing stops, pH should be at neutral 6-8. Provide adequate ventilation. Heat, carbon dioxide and hydrogen gas may be given off during neutralization. Collect residue in a suitable container. Place the broken battery in a heavy-duty plastic bag or other non-metallic container. Properly recycle all battery residue and parts.</p>

<b>SECTION VII: HANDLING AND STORAGE</b>
<p>Store in a cool; dry area away from combustibles. Do not store in sealed, unventilated areas. Avoid overheating and overcharging. Do not use organic solvents or other than manufactures recommended cleaners on the batteries.</p>

**SECTION VIII: EXPOSURE CONTROLS/PERSONAL PROTECTION**

**Engineering Controls:** General room ventilation is sufficient during normal use and handling. Do not install these batteries in a sealed, unventilated area.

**PERSONAL PROTECTIVE EQUIPMENT (DURING INSTALLATION OR IN THE EVENT OF BATTERY BREAKAGE)**

**Eye Protection** = Chemical goggles, safety glasses with sideshields and or a full-face shield.

**Protective gloves** = Rubber or neoprene

**Respiratory Protection** = NIOSH approved acid mist/organic vapor respirator, if OSHA PEL is exceeded.

**Other Protective Equipment** = Acid resistant apron or clothes.

**WORK PRACTICES:** Use standard lead-acid battery practices. Do not wear metallic jewelry when working with batteries. Use non-conductive tools only. Discharge static electricity prior to working on a battery. Maintain eyewash, fire extinguisher and emergency communication device in the work area.

**SECTION X: STABILITY AND REACTIVITY**

**STABILITY:** This battery and contents are stable.

**Conditions to avoid:** Overheating, overcharging which results in acid mist/Hydrogen generation.

**Incompatibility** (materials to avoid): Strong alkaline materials, conductive metals, organic solvents, spark or open flame.

**Hazardous Byproducts:** Hydrogen gas may be generated in an overcharged condition, in fire or at very high temperatures. In fire, may emit CO, CO<sub>2</sub> and Sulfur Oxides.

**Hazardous polymerization will not occur**

**SECTION XI: TOXICOLOGICAL INFORMATION – SULFURIC ACID**

The C&D VRLA batteries are a sealed, recombinant design that require no water replacement throughout their service life, thus no contact is made with the battery's internal components or chemical hazards. Under normal use and handling, these batteries do not emit regulated or hazardous substances.

**Carcinogenicity:** The International Agency on Cancer (IARCC) has classified "strong inorganic acid mists containing sulfuric acid" as a category 1 carcinogen (inhalation), a substance that is carcinogenic to humans. This classification does not apply to the liquid forms of sulfuric acid contained within the battery. Misuse of the product, such as overcharging, may result in the generation of sulfuric acid mist at high levels.

**SECTION XIII: DISPOSAL CONSIDERATIONS**

**Waste Disposal Method:** Send to lead smelter for reclamation following applicable Federal, State and Local regulations. Product can be recycled along with automotive (SLI) lead-acid batteries.

All C&D AGM batteries, when transported by air, surface or by vessel are identified as "**Battery, Electric Storage, Wet, Nonspillable, Not Regulated**".

The battery(s) must be identified as above on the Bill of Lading and properly packaged with their terminals protected from short circuit. NA or UN numbers do not apply.

C&D AGM battery(s) warning label identifies each battery as NONSPILLABLE.

C&D AGM battery(s) preprinted cartons identifies each battery as NONSPILLABLE.

C&D AGM battery(s) shipped without cartons (bulk packed) need to be Identified as NONSPILLABLE or NONSPILLABLE BATTERY on the outer packaging.

**Air:** C&D AGM batteries meet the conditions in IATA/ICAO Special Provision A48, A67, A164, and A183.
